**TO: CLOSING AGENTS FLORIDA HOUSING FINANCE CORPORATION  
SINGLE FAMILY HOMEOWNER MORTGAGE REVENUE BOND PROGRAM**

**RE: SPECIAL REQUIREMENTS OF THE PROGRAM**

The first mortgage and some second mortgages are being provided by the Florida Housing Finance Corporation's Single Family Mortgage Revenue Bond Program. These mortgages are exempt from documentary stamp tax and intangible tax.

? **Mortgages and Notes in this program are exempt from documentary stamp tax and intangible tax.** Deeds are not exempt. If the Note has preprinted or typed verbiage stating that the documentary stamp tax and intangible tax has been paid, it is to be "X"d out before being submitted for purchase. Each mortgage must have the following Mortgage Legend added: "THIS MORTGAGE IS GIVEN TO THE FLORIDA HOUSING FINANCE CORPORATION AND IS EXEMPT FROM TAXATION PURSUANT TO SECTIONS 199.183, 420.513(1), FLORIDA STATUTES", before submitted for purchase. If the verbiage is missing from the mortgage, it will need to be added to the original mortgage and re-recorded.

? **IF THESE FEES ARE CHARGED, PROOF OF REFUND MUST BE PROVIDED FOR THE LOAN TO BE PURCHASED.**

Buyers are not permitted to pay the fees on the deeds. This seller's expense must be paid by the seller.

Changes that occur at closing may affect the loan's compliance with tax law. Please check with the lender if any changes occur at closing including income, sales price and those who are to be listed on title.

Questions should be directed to the participating lender. Each county recorder has specific recording requirements for exempt loans. Closing agents should familiarize themselves with such conditions.
